
# The Impact of EU Law on National Private Law Competition, Internal Market, Directives, Ex Officio Application

# **12 May 2017, UNIDROIT**

"The impact of EU law on national private law; competition, internal market, directives, ex officio application". The conference will focus on the horizontal effects of EU law, which is to say its effects on relationships between individuals. To a large extent, these effects have been created by the Court of Justice of the European Union (CJEU) on the basis of the European Treaties.

The conference will address, in particular, the developments relating to primary EU law and their influence on national private law. Experts from both academia and practice will discuss instances where EU primary law has already directly or indirectly influenced case law in the Member States, or where it is expected to do so soon. Compared to the well-known impact of EU directives on private law, little attention has been paid in legal practice to developments concerning the effects of primary EU law on private law, and perhaps these aspects are not sufficiently explained by EU law scholars.

The conference finds its immediate cause in the publication of the Ius Commune Casebook on European Law and Private Law, which highlights developments in the areas of competition law, fundamental freedoms, non-discrimination, general principles of EU law, ex officio application of provisions of EU law and implementation of directives, including harmonious interpretation and Francovich liability. It presents national caselaw of ten Member States.

In its analysis of the ways in which EU law interacts with private law, the book will be an invaluable resource to practitioners, academics and students of EU private law.

The areas to be discussed during the conference are competition law, fundamental freedoms and the implementation of directives in relation with ex officio application. The presentations pursue three aims: presenting important results, making clear how to find thought provoking caselaw, and engaging the audience in a discussion on the state of the art and future developments.
